

INERTIAL SOLUTIONS LICENSE AGREEMENT FOR BETA FIRMWARE SOURCE CODE

Before you buy the Beta Firmware License, here are a few important things to know:

Beta means the firmware is still under development and can contain bugs. We welcome your feedback on the product, but please be advised that purchase of the Beta Firmware source code License is not an entitlement to firmware support. However, your purchase does provide an opportunity through direct contact to provide timely feedback of problems and suggestions that may shape the way the product is enhanced. (Contact by phone or by email support@inertialsolutions.us)

By purchasing a License, the customer gains the ability to customize the code, and is also entitled to receive updated source code revisions for a period of one year at each major baseline release. Baseline releases may occur two or three times per year (or more) at Inertial Solutions discretion. Customer notice of new Beta baseline release will be by email. Updates are distributed upon customer request by Internet download or by US mail.

The customer is responsible to create the hardware/firmware development environment with which to compile and with which to translate the code for storage into processor memory.

By purchasing the Firmware Source Code License, you indicate your acceptance of the following Beta Firmware License Agreement ("Agreement"). If you are purchasing the Firmware License in your capacity of employee/representative of a company or organization, you warrant that you are authorized to legally bind such company or organization. If you are not so authorized, please obtain acceptance of this Agreement from an authorized representative.

This Agreement between Inertial Solutions, 14588 Budwin Ln, Poway, CA, 92064, USA and You the User, is License to use, to modify, to compile the source code however you may wish in accordance with the following terms and conditions. The parties hereby agree as follows:

The agreement:

1. Inertial Solutions grants to the User (either as an individual or entity) a limited, non-exclusive, non-transferable, License to use, modify, compile the Beta Firmware Source Code or documentation for the User's own internal personal or business purposes. The cost of installation, maintenance, support, test, training, and all other cost to use the source code and/or documentation shall be borne by the User.
2. Inertial Solutions welcomes User feedback regarding the firmware, which can be sent to support@inertialsolutions.us. You the User agree that any feedback provided will contain no confidential information, and that Inertial Solutions will be free to use User feedback for any purpose whatsoever.
3. "Licensed Firmware" means all or a portion of the Licensed Firmware Source Code is owned by Inertial Solutions, including any modifications, improvements and re-releases provided by Inertial Solutions to the User.
4. The Firmware will be provided to You the User on an "AS IS" basis, in source code form only. At Inertial Solutions' discretion, Inertial Solutions may choose to offer upgraded levels of Firmware as newer levels become available. The Firmware will be delivered to you, on a "no charge basis", for a period of one year from Your purchase of the source code License.

Except as the Source Code and User modifications to it becomes a separate User asset when installed in binary form on the targeted hardware towards which it is compiled, linked, and on which it is stored for execution.

8. Unlike hardware products, the purchase of the License to the Source Code and the activation of this Limited License Agreement is non-refundable once the Source Code is shipped.

9. The Firmware Source Code as well as the related copyrights or other industrial or intellectual property rights, are the property of Inertial Solutions. The User acquires no title, right or interest in the source code other than the License rights granted herein. Title to and ownership of the source code, any reproductions and any documentation shall remain with Inertial Solutions.

10. The User agrees that unless prior written authorization is obtained from the relevant governmental authority, it will not export, re-export, or transship, directly or indirectly, the firmware Source Code or any technical data disclosed by the source code to or from any other country to which an applicable embargo or other trade restriction is imposed by the US or other Government.

General Provisions

No modification, amendment or waiver of any of the provisions of this Agreement shall be effective unless made in writing and signed by each party.

If any provision of this Agreement is held to be invalid or unenforceable under any circumstances, its application in any other circumstances and the remaining provisions of this Agreement shall not be affected.

This Agreement shall be governed by the law of the State of California and the parties hereby submit to the exclusive jurisdiction of the courts of the State of California, San Diego county.
